

OFF-SIGNER REQUIREMENTS

The below information is based on the current information and process being used to carry out Off-signing crew operations in Papua New Guinea in line with the Covid measures, NOC and approvals from other relevant government agencies and terminal protocols.

Disembarking Foreign Crew – Any Off-signing crew must undergo a PCR test returning a negative result 72 hours prior to boarding an outward flight from Port Moresby, in addition a rapid test will be taken prior to being allowed to check-in for the flight on the day of the outward flight from Port Moresby.

The below Guideline for Off-signer to ensure all requirements are met.

Vessel (Off-signing Crew)

Master is to provide the following information to assist with the application to the NOC Controller to approve disembarking crew from the ship and quarantine exemptions.

- Health Declarations forms (for Offsigners only) Attached
- Ship's Particulars
- Crew List
- Body Temperature records
- Last 10 Voyage Memo (vessel)
- Nil Decease on board declaration
- Personal details name, designation, copy of passport bio page and seaman book
- Flight details of Off-signers.
- Attached (I-APTF) to be completed by each off-signer.

Once above information is submitted to the agent, a NOC task sheet is compiled along with above documents to seek approval and exemption to **disembark crew** and **reduce hotel quarantine** based on flight itinerary to the NOC Controller.

This may take upto 14 working days to process and approvals are not guaranteed.

Important note: The exemption for reduced hotel quarantine days does not exempt off signing crew from all other Pandemic Directives/Measures. Crew are to quarantine in their assigned rooms for the duration of their reduced stay without exception. Individuals and Companies may be fined accordingly if they contravene the directives /measures in place.

Vessel arrival at port

- Prior to vessel arrival the Agent will notify the respective terminals of pending crew change.
- Off signing Crew passports will be stamped onboard or taken on shore to PNG customs to stamp arrival into country.

Crew Change (PPE to be worn at all times)

- On-signers transported to vessel
- Off signers transported direct to Hotel subject to NOC controller approval
- Offsigners to be taken to a medical facility for PCR (Polymerase Chain Reaction) tests 72 hours prior to boarding an aircraft and return a negative test.
- All necessary visa's to be in place for off-signers for transit destinations by crewing company.

Crew Change Restrictions

- Crew Change in Port Moresby only
- No crew change at ports or terminals is permissible unless approved by the NOC controller
- No OPL Crew Change authorised in PNG
- On shore Medical emergency requests must be approved by the NOC controller
- No shore leave.
- Crew to quarantine for the duration in their assigned hotel rooms for the reduced days approved.
