Crew Procedures

1. INBOUND TRAVEL REQUIREMENT TO BRUNEI FOR SIGN ON CREW

A) Inbound travellers are required to complete full course of COVID-19 vaccination under the WHO Emergency Use Listing (1 dose for Johnson & Johnson vaccine, 2 doses for all other vaccines).

Effective 1 November 2022, inbound travellers will only be permitted to enter Brunei Darussalam if the traveller has completed full course of COVID-19 vaccination not more than 3 months before departure or have obtained booster dose.

Fully Vaccinated travellers are no longer required to undergo Post arrival Covid19 test and mandatory self isolation at hotel accommodation.

B) Foreign nationals who will enter Brunei Darussalam for short-visit purpose in which the duration of stay in Brunei Darussalam is less than 90 days are required to obtain Travel Medical Insurance with COVID-19 coverage (minimum coverage of BND\$20,000). The insurance must be valid for the duration of their stay in Brunei Darussalam.

Kindly ensure that crew must have this document physically with them when entering Brunei :-

(This will need to be presented by crew upon arrival in Brunei to the airport counter $)\ .$

A) Outbound travellers are required to complete full course of COVID-19 vaccination under the WHO Emergency Use Listing (2 doses for all other vaccines).

Fully Vaccinated travellers are no longer required to undergo Post arrival Covid19 test and mandatory self isolation at hotel accommodation.

6. VISA REQUIREMENT

Nationalities that require Visa entry to Brunei are **NOT ALLOW** to enter Brunei until Visa is approved.

We can process Visa in Brunei for nationalities that require Visa.

Once Visa is approved , Visa copy will be email to you and crew must carry this Visa copy physically with them when flying into Brunei.

Crew must have BND 20.00 ready with them to pay at Brunei entry counter upon arrival.

Visa processing will need at least 5 working days (Friday & Sunday are Government non-working days).

7. TERMINAL REQUIREMENT

Please note that TERMINAL prohibits the crew change to take place during the loading/discharge operations while the vessel is at TERMINAL/SBM. This means that the crew change must take place while the vessel is at Anchorage either before the vessel enters TERMINAL/SPM or after the vessel has came out of TERMINAL/SBM after the completion of loading/discharge operations.

Please also take note that crew change can only be done during daylight time hour (0800 hours-1800 hours)
