### **COVID 19 PROTOCOLS FOR OFFSHORE SUPPLY VESSELS / RIGS / JACK UP BARGES ETC. CALLING RLC PORT**

**Dear All,**

Following review of new developments and visible reduction in the number of fresh COVID 19 cases, Ras Laffan Port Management has updated precautionary measures for Offshore Supply Vessels (OSVs), Jack Up Barges (JUB) and Jack Up Rigs (JURs) etc. as follows.

- a. Prior to leaving the port of departure, the vessel management shall ensure everybody onboard returns negative PCR test results for COVID 19.
- b. The vessel management shall regularly monitor the health condition of crew / passengers / supernumeraries and submit declarations of health as per RLC Port COVID 19 Protocol.
- c. Vessel management shall ensure that crew / passengers / supernumeraries are duly vaccinated against COVID 19 in line with international health guidelines.

Subject to the vessels meeting the above conditions, the 7 days quarantine period will be waived. On arrival, the vessel management shall book for Rapid Antigen Test (RAT) for all crew members through QatarEnergy health authorities and submit the results to Port management.

Vessel will be conferred with Free Pratique once negative test results are received. In case any crew member results are positive for COVID 19, the vessel shall wait for 7 days and arrange fresh Rapid Antigen Test for all crew members.

The above quarantine waiver shall not contravene any other requirements of QatarEnergy / State of Qatar and those of offshore field operators for which the vessel is required to work.

The effective date of the above changes shall be March 18, 2022.

We look forward for cooperation from all the port users.
