South Korea_ Quarantine/ Immigration regulation

for crew change under Covid-19

1. Quarantine regulation for crew changes

1) For on-signers

Isolation regulation

• All entrant crews must have 10 days self-quarantine in Government designated facility at their cost.

(Cost: KRW 120,000 / day)

- The entrant crews are transferred to isolation facility from ICN airport on their arrival for the PCR test and isolation.
- The registered agent will pick the on-signers up to the port immigration office.
- **(PCR test)** The on-signers are requested to have valid PCR test report at their departing location, which result shall be issued 72 hours within flight departure time. The joiners must carry the report along the journey until embarkation. Crews from **(Ref.2)** countries required to visit designated office for the test.
- **(VISA)** The on-signer are requested to acquire Korean Visa (C-3-11) prior to depart to Korea. It takes about 14 days regardless of nationality. However, crew from one of 49 countries (*Ref.1*) are exempted.

■ Early release (10 days -> 3-4 days) ►

- To apply for early release, the crew must have 'negative' PCR test result during isolation period.
- Shortened isolation is at least 3-4 days for PCR test and early release application.
- Early released joiners must depart Korea with vessel within 12 hours from release isolation facility.
 - * Joiners release time will follow vessel schedule. The crews cannot be released with unfixed schedule.
 - * If the vessel call more than one ports of Korea and early released crews will join, the crews will embark the vessel on 'last port' of departing Korea.
- (Risk) 10 days of isolation is obligatory to crews who shared flight or transportation with COVID-19 confirmed personnel during the journey.

2) For off-signers

- All off-signers must have a working phone number and mobile to run "Self-diagnosis" Apps. http://ncov.mohw.go.kr/selfcheck/
- * If the off-signer doesn't have working phone no, prepaid sim card(USD30) will be charged to run app.

Disembarkation of Crews

- All off-signers are requested to stay on-boarded for the result after PCR test at quarantine office on shore.
 * Depending a port situation, the test result comes out in 10 24(max) hours.
- Off-signers can take a departing flight within 12 hours from embarkation. The crews will stay at isolation facility if the flight schedule is over 12 hours from disembarkation.
- **(China)** If the off-signer's transit / destination is China mainland, the crews are requested to be isolated 14 days. After isolation, Visitation to China designated hospitals (*Ref.4*) for PCR & IgM test will be prepared.
- (India) If the off-signer's transit / destination India, hand carried PCR test report is requested by airline. The test will be taken during 4 days of isolation period.
- (Singapore) The off-signers who transit at Singapore airport shall have Vaccination certificate and PCR test certificate in prior to departure.
- (Philippines) Philippines crews shall have PCR test certificate at isolation facility in prior to their flight.

Embarkation & Disembarkation of Passengers

The personnel who will be on-boarded or off-boarded as passenger, service engineer, superintendent, or others are required to be isolated for 10 days in the isolation facility. The passengers cannot be early released.

3) General Crew Change

■ Restrictions ■

- The crew change cannot be performed during cargo operations, but at anchorage.
- The vessel with embarked crews from ports of Russia or Philippines cannot perform crew change in Korea ports in 14 days of embarkation date.

PCR test reports to call Korea

- The PCR test reports must be handed over to Agent who register the vessel to call Korea port.
- All PCR negative test reports must show the test method as 'Real-time Reverse Transcription Polymerase Chain Reaction' in order to pass airport immigration, port quarantine office, or any Korean Gov't Organization.
- The information in below must be shown in the PCR test report;
 - 1. Name
 - 2. Date of birth or Passport number.
 - Test Name & method
 Test result
 Test date

 - 6. Test result issue date
 - 7. Official stamp or signature from the test report issuing organization

Remarks

Covid-19 treatment coverage

- Countries are divided into three(3) categories as below and list of countries can be found (Ref.3)
 - Category 1: All medical treatment costs are fully supported by the Gov't
 - Category 2: Some medical treatment costs are partially supported by the Gov't
 - Category 3: All medical treatment costs shall be paid by him/herself (No support from the Gov't)
 - * Foreigners arriving Korea and violating any kind of quarantine regulation will be subject to pay the entire medical treatment costs by themselves.
