Please note that the Government of Curacao has revised their travel regulations to Curacao. Effective as of April 20th the following will be applicable for traveling to Curacao. **Please see below point 2 and 4 for an important update on traveling from high-risk countries!**

As of January 1, 2021, the Government of Curação amended the travel policy. Authorization by or on behalf of the Minister of General Affairs to enter Curação when traveling from a high-risk country or region is no longer a mandatory required because the Government of Curação decided to classify countries in either high or low-risk countries and amended the requirements thereof. This means that the exemption process will no longer exist.

As of April 20th 2021, the following countries have been classified as **low-risk**: Anguilla, Antigua & Barbuda, Bermuda, British Virgin Islands, Cayman Islands, Dominica, Grenada, Montserrat, Saba, Saint Barthelemy, Saint Kitts & Nevis, Saint Lucia, Saint Martin, St. Maarten, St. Eustatius, St Vincent & Grenadines, Turks and Caicos.

Traveling from low-risk countries or regions are required to take these two mandatory actions prior to departure:

- 1) If required, complete the digital immigration card online prior to departure at https://dicardcuracao.com/portal
- 2) Within 48 hours before departure, you must digitally complete the Passenger Location Card (PLC) at https://govcw.ibis-management.com/

Traveling from high-risk countries or regions are required to take these three mandatory steps before departure:

- 1) If required, complete the digital immigration card online prior to departure at https://dicardcuracao.com/portal
- 2) Within 48 hours prior to departure, you must complete the digital Passenger Locator Card (PLC) at https://govcw.ibis-management.com/ IMPORTANT: when filling in the PLC form online you will be asked reason for visit, please use the <a href="crew change" option. Even if you are just visiting the vessel and then departing by airplane again. When you chose "crew change" you will be asked for to enter the vessel or agency name.
- 3) Each traveler entering Curação must show upon arrival a negative COVID-19 PCR test result. (Please note that PCR tests based on Gargle samples will not be accepted). The test shall be performed not later than 72 hours before arrival in Curação by an accredited laboratory. You can contact your general practitioner about a referral to the nearest facility. **Negative COVID-19 PCR results must be uploaded to dicardcuração.com prior to departure.**
- 4) If you stay in Curacao (even if onboard) for 3 days or more you will need to do an Antigen test. This will be triggered by the dates you mention on the PLC form. If you state here that you will stay in Curacao for 3 days or more, you will need to book and pay for an Antigen test at least 48hrs before departing to Curacao. After completing the PLC form (bullet 2) you will receive a confirmation e-mail with a reference number (check your spam box). This reference number you will need for this step to book the antigen test. As of Tuesday April 20th 2021 all travelers from a high risk country to Curacao must take an antigen test three (3) days after arrival in Curacao. Each passenger must arrange an appointment and pay for the antigen test online via the website at least 48hours before departing to Curacao. This is the link: https://plc.misalu.live/ords/sq workspace/r/misalu/home. Payment must be done with a credit card. The antigen appointment confirmation must be submitted to us and hand carried on travels together with a negative PCR test not older than 72 hrs. (see bullet 3) and the passenger locator form (see bullet 2). All these documents (print out) must also be submitted hard copy upon arrival in Curacao, but it is not allowed anymore to fill these in on arrival, they have to be completed online prior arrival in Curacao.

Passengers leaving Curacao withing 3 days of arriving (with the vessel for example or by air) are not required to do the antigen test after arrival. If a traveler is planning to stay shorter than 3 days but ends up staying longer than 3 days this is no problem but then the test must be done. In this situation we will book the test for you and take care that the test result gets submitted. Your OKTB must be shown at immigrations to confirm you will attend a vessel and your agent.

IMPORTANT: We need a copy of the online completed PLC form and online antigen test booking confirmation (if applicable) at least 48hrs before departing to Curacao (please send to us by mail). Without these documents in advance passengers will not be allowed on the island and will most likely already be rejected boarding at the airport for the flight to Curacao. Please note.

Aside from the above COVID regulations all other formalities and regulations remain in place. OKTB must still be hand carried and Curacao's VISA policy has to be upheld, see attached.

Local Covid tests can performed and are for the account of the individual/company. Current rate for PCR test is USD 150,- per test, subject to change. Current rate for Antigen test is USD 70,-, subject to change.

Off singers may still disembark at any time! Subject to last ports and voyage they can go to quarantine or regular hotel, PCR test might be needed which we can arrange. Straight to the airport is always also possible for their onwards flight. If off signers stay in Curacao for 3 days or more, they will also need do the Antigen test on day 3.
